## Finance Update – Mike Cruise

#### Monthly Revenues and Expenses:

The month of March resulted in an operating margin of \$49,117, which is 1.9% of revenue. This is \$91,961 favorable to the budget which is -\$42,844. Revenue was unfavorable for the month by \$201,297. As a repeat from last month the two primary causes are voice revenues continuing to be down as they have for the entire fiscal year and not having much billed for cost

recovery of OSP expenses. Direct expenses are favorable to budget by \$113,000. Total allocated indirect expenses are \$180,258 favorable to budget.

#### Year-to-Date (YTD) Revenues and Expenses:

(ex officio)

Through March, we now have an operating margin of \$717,999, which is \$770,192 favorable to the budget, which is still negative at \$52,193. Revenue is \$142,505 unfavorable to budget, which marks the first time this fiscal year we have been under budget for YTD revenues. Direct expenses are favorable to budget by \$540,809. Total allocated expenses are now \$371,889 favorable to budget.

#### Comparison to March FY 2022:

The current year operating margin for the month of March is \$207,000 favorable to March FY 2022. Revenue is unfavorable by \$106,000 compared to last March. Direct expenses are \$364,000 favorable. Total allocated expenses are favorable by \$51,000.

Question from Commissioner Mason - Why are the direct expenses so low?

Mike Cruise explained that we have completed several cost cutting measures to remove the expenses we don't need. One big gain was with the maintenance on equipment, we have a surplus that we can use for spares. We don't need to carry extra maintenance on equipment, it is mostly software.

Scott Pappan added that we are working on the core contract. The team worked on the edge contract, and we are doing the same thing with the core network.

#### Year-to-Date Comparison to FY 2022:

Operating margin is nearly \$1.6M favorable through March. This includes revenue being up \$780,000, direct expenses are \$1.3M favorable and indirect expenses at \$452,000 unfavorable.

- FY 2024 Budget Second draft of FY 2024 budget has been distributed to the executive team for their review and input. Those are due by April 21. The third draft of the budget will be distributed to the ITTC Finance committee on April 28.

# **Network Operations & Security Update – Ryan Mulhall**

- Aggregation Replacement: On hold right now, waiting for a different version of code from our vendor. We are about 15% completed with the project. There are other components moving within that aggregation layer, including our annual reboot of our legacy aggregation boxes. Once a year we reboot that hardware. We received some additional hardware from a vendor after a long wait time, and we are preparing those in the lab right now.
- DDoS Platform: We have installed and powered on additional hardware and brought software online for our DDoS service. We were going to start migrating, but had some additional dependences on another component. May take a couple months to be completed.
- Outside Plant: In March there were 17 new projects started. This is a little below average due to weather and a slow start to the construction season. There were 3 cable cuts that will be billed back to contractors via partners or executive council claims. We have seen an uptick in April.
- Open Position: We do have an opening for an Outside Plant Junior Engineer position. This is in the hiring phrase. This closes on April 27. Hope to have someone ready to go in mid-late May.
- Grants: We are getting ready to close out one grant from Iowa HSEMD. We need to complete that by June 30. We have two more in progress that we were awarded. One is waiting on equipment to be shipped and the other grant we will start ordering equipment soon. Those are from the most recent grant year. We also have four other grant applications in the 2023-year program. We usually get notification in September/October timeframe.

- Sioux City AEA is relocating to a new building. We are still in the discovery phase.
- Iowa Wesleyan University is closing at the end of the school year and the USDA will assume ownership of the campus following closure. We are working on the next steps.
- For a remodeling project, the architects for Indianola high school have reached out to ICN to begin discussions for our needs as they start work on the remodel and addition to the high school. Everything is moving on a positive note as we move forward.

Blake DeRouchey said an A. Throughout the transition to ESF, the ICN role was more ICN Network focused and we greatly expanded it. When you look at the players, ICN was uniquely situated to be the lead. When we tabbed ICN, there was collaboration on who the best person and how that role looked. It was an expansion of information normally on the health of the network, now it is operational working across various departments and states to help with the communications mission. Speaking from the 911 program manager perspective as well, we can't do our job managing the network without ICN.

## Presentation: Iowa National Guard (ING), Lt. Colonel Erick Eggers

Provided an overview of the ING. ING provides support to 46 employees that help manage the enterprise environment. ICN provides services to 44 different armories and facilities across the State. ICN provides circuits for us to do our job. The response time that we get when we have an issue is incredible. The staff has been great. ICN provides data transport, voice/SIP services, and external telephony calls. We also have a data recovery offsite information system over in Boone. What the ICN allows us to do is invaluable.

On the military side, the ICN allows us the capability to do election support. With the ING defensive team and the cyber operations team, there is a joint team to help support the OCIO come election time. Having the ICN connection and being able to place sensors when we need to, to help manage vulnerabilities. ICN provides the capabilities to do these types of things.
